4. The proposed school shall not use the premises including staff. play ground or any moveable or immovable property of any other school registered under the respective Act of state Government.
5. The state Government will not bear any financial or administrative responsibility of the proposed school. The state Government will not be responsible. If the school/ institution breached of any rules/norms or regulations laid down by above said board.
6. The institution shall have to obtain necessary permission of Government of India and other concerned authorities where it is necessary
